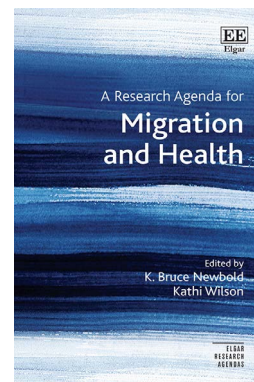


A Research Agenda for Migration and Health
